Objectives of the project

The objectives of ARIEES are to help universities (and potentially adult training centres) to improve their entrepreneurship courses by infusing impact investment know-how and to upgrade the digital competences of lecturers/trainers to ensure that the impact investment knowledge can be properly infused into the learners.

Specific objectives of the project:
